ust concluded Bihar assembly

elections have brought to the

fore two surprising elements which

may change political equations in the

future, though in limited extent. First

is, the rise of Asaduddin Owaisi's All

India Mailis-e-Ittehadul Muslimeen in

Bihar, who has got five seats in the state

assembly. This is very surprising as

political polarization of such an extent

has never been seen in Bihar. Though

Bihar is a state where, communal

equations matter most. But, the

voters had never voted tremendously

to a purely communal party which

is confined to a single minority

community. This is a very danger

sign for entire Indian polity. AIMIM's

entry into assembly is an indication of

new era in Bihar as the party will be

detrimental to Congress. The reason is

obvious. Congress considers Muslim

vote bank is its reserved treasure. But,

AIMIM has shaken that belief though

in little extent. Congress will have to

change its strategy in future if it has

to win the elections. Muslims do not

trust Congress and they have gone

far away from the party after Babri

demolition. Now, they have got a pure

option of a party which is committed to

their welfare. They firmly believe that,

Congress has done only lip service

so far for them. Not only in Bihar, in every election in future, AIMIM will

continue to harass Congress by eating

out their votes. It is very interesting to

note that, originally a small party with

roots in the Old City in Hyderabad —

has won five seats in the assembly.

Mr Owaisi has been making a

concerted effort to expand his party's

base in Bihar's Seemanchal region,

particularly Kishanganj — which has

for over five years now. It won a by-

poll in the region last year, but has

emerged as a major force this time

around. The rise of AIMIM has given a

severe setback to Congress, which has

shown extremely dismal performance.

Though AIMIM has got only five seats,

it has affected voters mindset in

other constituencies. Mr Owaisi is a

controversial figure. While he speaks

the language of constitutionalism and

seeks rights for Muslims and other

marginalized groups, his party has

often engaged in extremist rhetoric and

even hate speech. But what explains

his growing popularity, with his party

winning seats in places as varied as

Maharashtra and Bihar? As Congress'

appeasement of Muslims has given

strength to BJP which has emerge

from Hindu backlash, AIMIM has also

gained ground due to Congress only lip

service to minorities. Muslims in India,

after the trauma of Partition, have

been sceptical of solely identity-based

political formations and have invested

their lot with secular formations and stuck to the democratic mainstream. But the rise of the Bharatiya Janata

Party (BJP) has led to greater alienation

parties to fight the BJP, and increasing disillusionment with these forces, has also led to a search for alternatives.

Those criticising Owaisi for "cutting"

the votes of other Opposition parties are doing a disservice to Indian

democracy, for he is as entitled to participate and contest elections as

any other formation. On his part, Mr

Owaisi must consistently ensure that

his party remains wedded to the plural, peaceful, democratic, constitutional

path and doesn't engage in minority

communalism. The second surprising

element is while on one hand

communal party is emerging in Bihar,

left parties got some sizable presence

in assembly. They have got sixteen

seats which is not bad in the wake of

their dismal performance elsewhere. A communal party is entering Bihar assembly and at the same time secular left parties have sizable presence is a very surprising element. Bihar people's mindset is divided in various ideologies and the recent results is its manifestation.
